Revised FY 2019 Territorial Education Facilities Fund (TEFF) Reductions

On January 2, 2019, the BBMR and the Department of Administration (DOA) placed your FY2019 TEFF allotments in Reserve in order to address the approximately \$9M projected TEFF revenue shortfall. Your respective required pro-rata TEFF reduction levels were also provided to each of your agencies/departments individually.

Based on the Special Revenue Tracking Report for the TEFF for the month of May 2019 the TEFF is still on a negative track, however, it is anticipated to incur a revenue shortfall of \$3.8M. Because of this lower shortfall, the Bureau has revised its TEFF reductions to allow for the partial release of TEFF allotments currently held in reserves for your entity's operational requirements.

The Bureau will be taking action to adjust your FY2019 TEFF allotments in Reserve and will be working with the Department of Administration to take the required measures for entities that are exempt from BBMR allotment control. As such, your respective entity's required TEFF spending reduction as adjusted is / are reflected in the attachment to this memorandum.

As was requested in our previous memorandum, the Bureau is once again requesting for a written action plan from your agency/departments which outlines how it will meet your revised TEFF level(s) which may include both cost-cutting and revenue enhancement measures. This plan will be due to the Bureau no later than the close of business Friday, July 19th, 2019 and serve as the trigger for BBMR and DoA to revise your TEFF allocations. Thank you in advance for your cooperation.
